NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Sanskrit Education State and Subordinate Service (School Branch) Rules, 2015, namely:-

1. Short title and Commencement- (1) These rules may be called the Rajasthan Sanskrit Education State and Subordinate Service (School Branch) (Amendment) Rules, 2018.

(2) They shall come into force with immediate effect.

2. Amendment of Schedule-I- In Schedule-I appended to the Rajasthan Sanskrit Education State and Subordinate Service (School Branch) Rules, 2015, hereinafter referred to as the said rules,-

(i) the existing serial number 4, 5 and entries thereto shall be substituted by the following, namely:-

4.	Principal, Varishtha Upadhyaya School	100% by promotion out of which 20% from Head Master, Praveshika School / Senior Deputy Inspector, and 80% from Lecturer/ Deputy Inspector.	-	1.
